The CSR Committee is tasked with formulating and recommending CSR policies, identifying projects, allocating resources, and ensuring compliance with all regulatory requirements.

6. CSR Activities in Practice

At SJCPL, we have established a range of CSR activities that reflect our commitment to social responsibility, environmental sustainability, and community well-being. Our ongoing initiatives include:

9. CSR Funds Allocation

The corpus for carrying out SJCPL's Corporate Social Responsibility (CSR) activities will include the following:

- 2% of the Average Net Profit: A minimum of 2% of the average net profit made by the company during the three immediately preceding financial years will be allocated towards CSR activities, in compliance with the Companies Act, 2013.
- Surplus from CSR Activities: Any surplus arising out of the CSR activities undertaken by the company will be reinvested into CSR initiatives and will not be considered as part of the company's business profits.
- Flexibility in Fund Allocation: While we strive to adhere to our planned budget allocations, SJCPL maintains a degree of flexibility to respond to additional emerging needs and opportunities. This allows us to allocate additional funds to urgent or high-impact projects that may arise during the financial year.
- **Unspent Amounts:** Any unspent CSR amount will be transferred to a designated bank account earmarked for CSR spending or contributed to a government-approved fund within six months of the financial year-end.





10. Implementation Methodology

To ensure the effective execution of our Corporate Social Responsibility (CSR) initiatives, the Board of Directors at SJCPL has established a dedicated CSR Committee comprising three Directors. This committee is entrusted with the following key responsibilities:

- Formulation and Recommendation of CSR Policy: The CSR Committee is responsible for formulating and recommending to the Board a comprehensive Corporate Social Responsibility Policy. This policy outlines the specific activities and projects to be undertaken by the company, in accordance with Schedule VII of the Companies Act, 2013.
- 2. **Budget Recommendations:** The committee is tasked with recommending the appropriate allocation of funds for the CSR activities specified in the policy. This ensures that adequate financial resources are directed towards impactful and sustainable projects.
- 3. Monitoring and Evaluation: The CSR Committee continuously monitors the implementation of the Corporate Social Responsibility Policy, ensuring that all activities are carried out in alignment with the company's goals and regulatory requirements. The committee is also responsible for making periodic adjustments to the policy as needed to reflect changing priorities and emerging needs.

In addition, the Board of Directors has mandated that one Director from the CSR Committee will be responsible for reviewing the annual progress reports submitted by the appointed implementing NGO. This review process ensures transparency, accountability, and that the CSR initiatives are progressing as planned and achieving the desired impact.

11. Implementing Agencies

Organisations must have:

- 1. Trust, Society and Section 8 Company Registration Certificate
- 2. 12 A and 80G Certification
- 3. Niti Aayog Registration
- 4. Registration with the Ministry of Corporate Affairs as CSR Implementing Agency by filing Form CSR-1.

While we collaborate with this specialised agency to leverage their expertise, SJCPL is also committed to implementing certain CSR activities directly. By doing so, we aim to maintain a hands-on approach, allowing us to stay closely connected to the communities we serve and ensure that our initiatives are aligned with our core values and objectives.

12. Monitoring

The submitted report will be reviewed by the CSR Committee, which will provide its appraisal and any necessary comments. The committee's feedback, along with the report, will then be presented to the Board of Directors for their consideration and further action as needed.
